#### **4:10 p.m. Windham Regional Transportation Plan Policy Update Discussion**

The Committee will begin discussing policy updates of the Windham Regional Transportation Plan as part of the ongoing update to the Windham Regional Plan. The Committee reviewed the existing plan and policies at the February meeting. Readopted in 2021, the Transportation Plan currently exists as a standalone document separate from the overarching Windham Regional Plan. One of the goals of this update is to incorporate transportation as a section of the larger Windham Regional Plan. The Committee will work over the next several months to create a draft update of the transportation section, revising the existing document to reflect the most current trends and needs of the region, and outlining forward looking policies relevant to the towns and residents of the Windham Region.

#### **4:40 p.m. Review of Draft Transportation Advisory Committee Municipal Outreach Letter**

The Committee will review a draft of a letter to towns informing them of the changes to the Windham Regional Transportation Committee and the opportunity to appoint a representative to the Transportation Advisory Committee.
